During the quarter, an additional \$31,000 loan was provided by a Director of the company for working capital purposes.

A new loan of \$250,000 was provided by a Company associated with a substantial shareholder during the quarter. This loan will be secured by the assets of the Company subject to shareholder approval, interest payable of 8% per annum and repayable by 30 March 2022.

A portion of this new loan was used to pay down director loan of \$41,000.

8.8.1. Does the entity expect that it will continue to have the current level of net operating cash flows for the time being and, if not, why not?

Answer: The Company expects that the outflow for the December 2020 quarter will be lower than the outflow in the September quarter. Operating cash outflows beyond the December quarter will be in line with the December quarter, subject to available funding.

8.8.2. Has the entity taken any steps, or does it propose to take any steps, to raise further cash to fund its operations and, if so, what are those steps and how likely does it believe that they will be successful?

Answer: Yes, the Board is talking to its major shareholders as well as third parties who are interested to provide funding through a combination of equity and debt structure. Funds may also be available through upfront cash contribution by prospective joint venture partners and /or partial sale of assets. In the meantime, the Company continues to receive loan funding from a director and also a major shareholder in the Company.

Answer: Yes, the Company expects to be able to continue its operations and meet its business objectives on the basis that it will be able to raise further cash as indicated in (2) above. The Company also notes that it has substantially reduced its corporate overhead costs.
