

## Quarterly Activities Report December 2020

---

### **Kurnalpi Project (100% KGM)**

The Kurnalpi project is located approximately 85km north-east of Kalgoorlie with easy road access. It has been subject to extensive historic small scale gold mining and a number of companies have completed extensive work on this project previously. A series of small to moderate size mineral resources have been defined in the project area and KalNorth is focusing on exploration to define additional resources to increase the potential for development.

During the Quarter, the Company continued reviewing exploration potential and targets which were identified from previous works and further drilling programmes will be planned accordingly. Other than desktop studies, no substantive exploration activities were undertaken at the Kurnalpi Project during the Quarter.

### **Lindsays Project (100% KGM)**

During the Quarter, the Company announced execution of a binding agreement for the sale of the Lindsay's project to Lindsays Find Pty Ltd (the "Buyer"), a wholly owned subsidiary of Nu Fortune Gold Limited, an unlisted public company involved in the exploration and production of gold in the Eastern Goldfields area of Western Australia – refer ASX announcement dated 4 December 2020.

A number of conditions precedent had to be satisfied (or waived) and the Company is pleased to advise that the last of the conditions precedent has been waived by the Buyer. The sale agreement is now unconditional and the Completion Date is 29 March 2020 (or earlier at the discretion of the Buyer) with the initial consideration of \$2.4M cash receivable on the Completion Date.

### **Exploration Expenditure**

Cash outflows on exploration and evaluation activity in the December 2020 quarter amounted to approximately \$90k (approximately \$128k in the previous quarter reflecting the settlement of outstanding liabilities from the previous quarter).

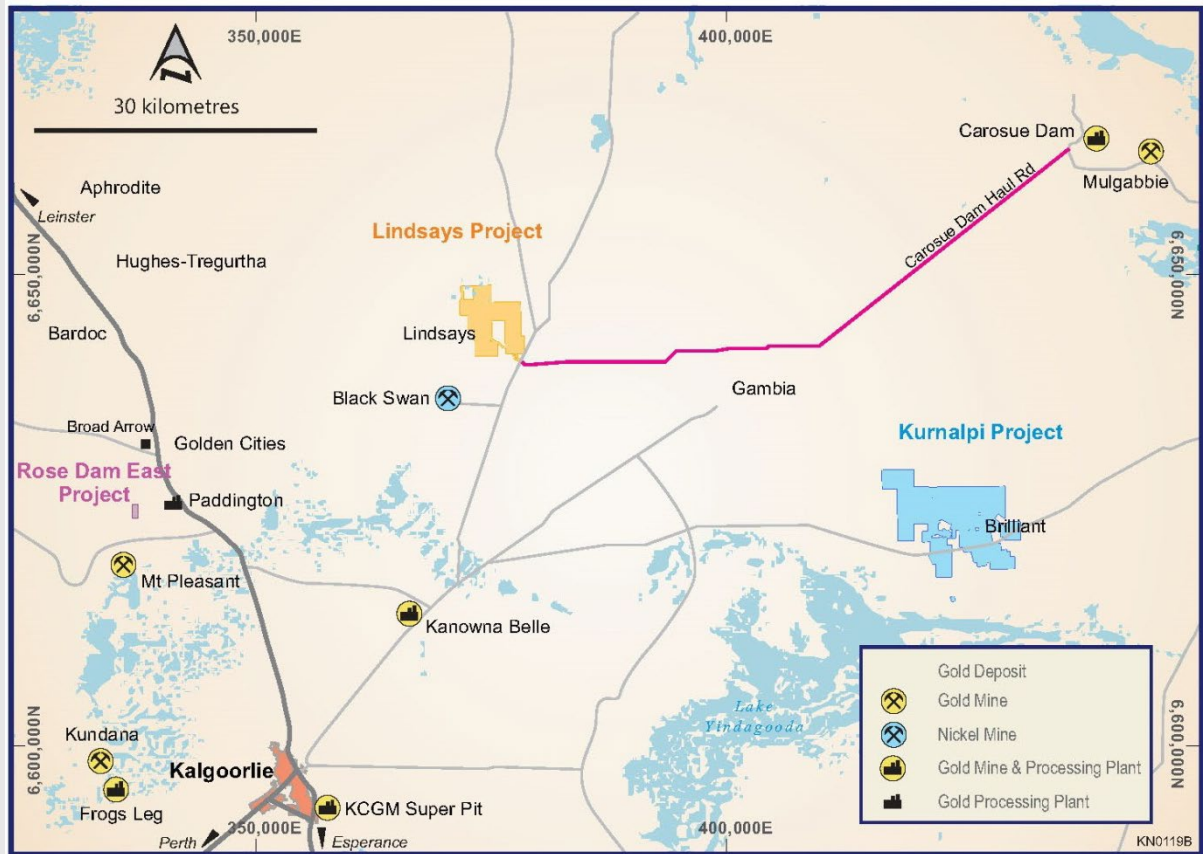
### **Related party payments**
